## Terms and Conditions for Installation Service

- \* We offer installation services for Ed Brown parts only; we do not offer gunsmithing or any other custom modifications or machining operations such as checkering your frame.
- \* We work on blue or stainless guns only. No aluminum or special finish guns of any type can be accommodated. This includes but is not limited to Parkerizing, Hard-chrome, or any type of coating except for our own Gen III coating. We can accept work on high polish stainless steel but at additional charge, subject to a quotation after an "in-shop" evaluation.
- \* For application of our Gen III coating, we accept **complete and assembled Ed Brown firearms only**. Even if you want the slide only on your handgun coated, sending the entire handgun is required. After coating, the firearm is returned to you fully assembled. On the rifles, all metal is coated, except the scope rings. On the handguns, all metal is coated, except the sights, barrel and bushing, trigger, springs, and small pins. Handgun grips are also not coated.
- \* **We will not deactivate any safety device for any reason.** If we find any safety device to be disabled or missing, we **must replace it and charge you for it**. This does not include trigger locks such as the ILS housing system.
- \* Payment is due in full at the time of completion and must be received before the gun leaves our shop. We recommend you send full payment with the firearm, as our turnaround time is seldom longer than 2 weeks, and if we must contact you for payment arrangements your order is unnecessarily delayed. Acceptable forms of payment include Visa, MasterCard, or certified funds. All personal checks will be a minimum of 10 days for clearance.
- \* All firearm **parts** may be sent through the US mail **except the frame**. Use UPS or FedEx overnight service for a complete handgun or frame only. Shipping regulations **require** Next Day Air shipping - adult signature required, for **all handguns**, which costs \$40. A handgun is considered to be the serial numbered frame. If you only need to send in the slide, you can use the regular ground service for return shipping, which costs \$9.25 fully insured.
- \*Effective April 24, 2006, pursuant to the Child Safety Lock Act of 2005, every firearm or handgun frame shipped to us by anyone other than a valid FFL holder, must include a gun lock, such as a cable lock. If it does not, we must supply one and charge you for it before releasing the firearm for shipment or pick-up. The cable-locks we stock are \$5 each.
- \* Please do not send any items not necessary for performing the work, shipping cases and gun locks are the only exception. Please include your name and address securely taped to any gun case you use for shipping your firearm to us.
- \* Shop times average less than two weeks.
- \* A \$25 minimum order charge applies.
